On 07-05-2005 Ofc. Reid and myself, Ofc. Fritz, responded to 1118 Lakeview for a domestic that was called in by a child. The child reported that his parents were fighting and that one of them had a knife. Upon arrival I spoke to Mr. Andrew Goss. Ofc. Reid spoke to his Mrs. Shakia Goss. Mr. and Mrs. Goss live at the Lakeview address together with their six children.

Mr. Goss reported that his wife was upset with him and suspected him of cheating. She began to hit him with her fists, push, and scratch him. Mr. Goss stated that the children were present during the assault. Mr. Goss reported that Shakia picked up a knife off of the counter, held it up in a threatening manner, and threatened to kill him. Mr. Goss stated that he grabbed his wives hands to prevent her from stabbing him. She has threatened to have him killed in the past as well. Mr. Goss had scratches all around his neck and on his shoulders. Mr. Goss wrote a statement and was given a blue card.

I spoke to Mrs. Goss who stated that when she went to hit her husband she knocked the knife off of the counter and then picked it up. She stated that she then set it on the counter. I asked Mrs. Goss if her husband hit her. She stated that he pushed her also but that it was no big deal and she had no marks. I spoke to De'Andre Goss who stated that he saw his mother holding the knife behind her back. De'Andre then saw his mother hold up the knife. At that point he heard his mother threaten to kill his father.

Mrs. Goss was placed under arrest. Ofc. Reid transported her to booking. Mrs. Goss signed a Miranda waiver and wrote a statement. I called Protective Services and spoke to Ms. Matthews. A copy of the report and a 3200 were faxed. I logged the knife into bin 57.

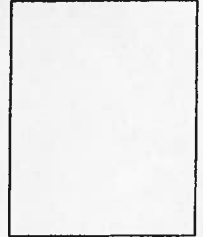
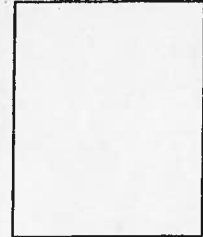

01 On Sunday, July 5, 2009, I, Andrew L Goss, was assaulted and battered by
 02 my wife, Shakia D Goss. Shakia suspected that I was cheating, which
 03 I vehemently deny, and she began to ~~talk~~^{curse} at me. Shakia hit me
 04 with her fists and slapped me with her hands. Shakia scratched
 05 and pushed me.

06
 07 I did not fight back, however I did use my hands and arms to deflect
 08 ~~the~~ Shakia's attacks. While my six children watched, Shakia grabbed a
 09 knife and said she was going to kill me. I take Shakia's death
 10 threats seriously because she has repeatedly threatened to
 11 kill me over the past couple of years. Shakia has said that she
 12 had already set up death-kills on me and all she had to do was make
 13 a phone call. Because Shakia has hung out at some very seedy places
 14 the past couple of years, I have no doubt that she is not bluffing.

 16 When Shakia tried to stab me, I held her hands and told my oldest
 17 son, De'Andre, to call 911. He knew that I was serious because
 18 I had him dial 911 the last time Shakia was holding me hostage,
