Dear Mr. Rogers:

This letter will confirm that we have agreed to the following terms as Temporary Orders in this matter:

- 1) <u>Conservatorship:</u> Parties will be named Joint Managing Conservators with each parent having independent rights and duties. Parties agree to reserve the naming of a primary parent until after a social study has taken place.
- 2) Visitation: Shakia Goss will be entitled to liberal access with the Children under a Standard Possession Order beginning Thursday, May 13, 2015. Parties may agree to additional visitation. This standard possession order excludes the oldest Child, De'Andre Goss. Parties agree that De'Andre may visit Shakia Goss when he wants to. Summer visitation will begin for Shakia Goss beginning June 26, 2015 and ending July 26, 2015.
- 3) Child Support: Parties agree no support to be paid by either party at this time.
- 4) <u>Daycare Expenses:</u> Parties agree that daycare expenses of the Children will be shared. Shakia Goss will give \$300 to Mr. Goss every other Friday beginning June 5, 2015 to share in daycare expenses.
- 5) <u>Social Study:</u> Parties agree to a social study and costs to be shared equally between the parties. Attorneys will decide on caseworker within 14 days.
- 6) <u>Counseling:</u> Parties agree to the Children attending regular counseling session, pending insurance approval. Parties will agree upon counselor.

- 7) <u>Father's Day Weekend:</u> Shakia Goss agrees to allow Children to remain with Father during Father's Day weekend.
- 8) <u>Church Attendance:</u> Parties agree that when they have the Children in their possession, Children will attend church at Hope Center Church.
- 9) <u>Mutual Injunction:</u> Parties will continue to adhere to a mutual injunction, including an injunction precluding each party from speaking with the Children regarding this case.
- 10) <u>Protective Order:</u> Parties agree to lift Protective Order currently restricting Shakia Goss.
- 11) Loving and Caring Order: Parties agree to adhere to a Loving and Caring Order.
